# Q1

- What are the main areas and actions of coordination between the Ministries of Education and Labor in your country?
  - actions in the field of teacher training (CENASU),
  - the link between education and professional training (TVE),
  - actions to facilitate the school-to-work transition, among others Foundation of Labour mobilization and Development (SAO).
  - facilitation of training locations for the SAO in different districts.
  - with regard to the SNTA, close collaboration between the working arms of the MoLEYA and the SNTA which is a working arm of the MoESC
  - representation of the MoESC in the advisory board of the SAO and other critical committee's that are dealing with the labour market.





### **Teacher training** (CENASU)

- In 2011, the Ministry of Education, Science, and Culture launched the Teacher Training Centre Suriname (CENASU), which focuses on the professional development of teachers.
- In-service teachers are being trained in new or modern themes on educational and management skills.
- As the Ministry started 2021 to focus on child-centered learning (OGO) the teachers are being trained in developing their curriculum and assessment based on OGO. Also how to implement and use the new learning materiales that we develop for grade 6, 7 and 8 of primary education.

## Actions to facilitate the school-to-work transition

- Assessment of and consultation with all education and training institutes with the potential to deliver a work based learning concept together with the MoEDC, the MoLEYA and her vocational institutes;
- Consultation of employers organizations to present the concept;
- Development of a functioning and inclusive work-based learning system with the consultation and collaboration of MoEDC, MoLEYA and employers(Decent Work Country Programma 3, priority 2/ Mid-term Labourmarket policy document 2022-2026);







#### What are the main successes and lessons learned from the actions indicated in the previous question?

- participation of working arms especially SAO to fairs organized by the MoEDC (recently the education fair);
- good collaboration and data sharing between MoEDC and MoLEYA(Labourmarket department) and also the SNTA and MoLEYA with regard to the share of labour market information;
- During the years , it is noticed that the current education system miss a link with the second chance education (SAO). Not all students from the SAO can flow through the formal vocational education.





# Policy goals

- Better and effective communication and coordination among educational institutions, Government, and industry to contribute to
- coherent and market-relevance training programs (National Development Plan of Suriname)
- Sufficient opportunities for work-based learning to prepare jobready candidates;
- A strengthened institutional framework and constituent capacity to implement an integrated, market-led, and competencies-based national training system.
